

#### MY MOTHER

When I was very young, my mother told me that when she was young, one of her neighbors aborted with the help of a mammana, drinking parsley infusions. Her cries of, before dying, were heard by the whole neighborhood. This story marked me, because up until about twenty days before my birth, this story represented daily life for women. And now it risks becoming so again.



#### MY DEAR FRIEND, MARINA

She was a feminist, She the feminist entered movement in Rome during the 60s/70S, when she was young and she became an ostetrician. I knew her during my political activism and thanks to her I'm a feminist. She used to talk to me about all the abuses taking place in hospitals against aborting women. She died in 2013.



## MY AUNT (MY FATHER'S SISTER)

she is part of the abortion team of the hospital in my city, she voluntarily chose to be part of it, because the large number of objectors makes access to abortion difficult.

#### LAW 194/1978

Rules for the social protection of maternity and the voluntary interruption of pregnancy

#### BEFORE THE LAW

Penal Code of 1930: it included abortion as one of the crimes against the integrity and sanity of the bloodline



60's/70's

- Thanks to feminist movements and journalists from UDI (Women's Union Italy), women started to speak about their abortion stories, and the publication of those stories was a shock for Italian society. Women, in that period, had the right to vote and the access to work, but they had difficult to make in discussion their role of mothers, patriarchy was very strong in Italy, and religious moral was influencing them too.
- Women learned to do abortions through the experiences of their mothers and other women. Men often asked their wives to learn it, and do it themselves in order not to circulate voices.

On 18 February 1975, a ruling by the Constitutional Court established that the mother's health and rights should prevail over those of the unborn child. The ruling created the first glimmer of legitimacy for that legislative process that will lead to Law 194.





29 APRIL1975 the Parliament approved the establishment of family counseling centers, which had among their objectives the dissemination of contraception




# LAW APPROVAL



- January 21, 1977: the House, with 310 votes in favor and 296 against, approves the bill Norms on the interruption of pregnancy, the result of discussions lasting months and a synthesis between the proposals of the various parties.
- The approval path was marked by contrasting positions, proposals for changes, attempts at conciliation with the positions of the Church
- May 21, 1978: the law was approved in the Senate with 160 votes in favor and 148 against



# 17 MAY 1981 political groups and religious movements proposed 5 referendum to repeal the law: ITALIANS VOTED CONFIRMING THE LAW

The State guarantees the right to conscious and responsible procreation.

It recognizes the social value of motherhood and protects human life from its beginning. The voluntary termination of pregnancy, referred to in this law, is not a tool for birth control. The State, the regions and local authorities, within the scope of their functions and competences, promote and develop social and \*health services, as well as other initiatives necessary to prevent abortion being used for the nurnose of limiting births.

- The voluntary interruption of pregnancy, after the first ninety days, can be practiced:
  - a) when pregnancy or childbirth carries a serious danger to the life of the woman;
  - b) when disease processes are established, including those relating to significant anomalies or malformations of the unborn child, which cause a serious danger to the physical or mental health of the woman.
- For minors and interdicted women, the possibility of abortion is ensured through authorization by parents or legal representative

Healthcare personnel and auxiliary activities are not required to take part in the procedures envisaged and interventions for interrupting pregnancy when you raise conscientious objection, with prior declaration. In any case, hospitals and authorized nursing homes are required to ensure that the required procedures are carried out and that the interruption interventions requested are carried out according to the established procedures. The region monitors and guarantees their implementation also through mobility of the staff. Conscientious objection cannot be invoked by health personnel, and carries out auxiliary activities when, given the particular circumstances, their personal intervention is essential to save the life of the woman in imminent danger

## RIGHT TO OBJECT???

In 1978 it had a sense (in fact, it should have been a transitional rule!!) because a lot of doctors started their careers when abortion was a crime. Over the years, this rule has only the function of boycotting the access to abortion because, despite the law says that regions have to guarantee that access, we have more than 70% of objectors in Italy



The path is very difficult: a woman decides to have an abortion, she goes to the doctor who has to speak with her, she has to wait 7 days for "thinking about her choice", and then face the obstacles due to the presence of objectors.

### BOYCOTT LAW 194 WITHOUT A DIRECT ATTACK...



In Italy, 7 out of 10 gynecologists in hospitals are objectors. The objection rate exceeds 80% in seven regions.

Molise: 96,4% gynecologists and 71.9%

anesthesiologists

Basilicata: 88% gynecologists, 71% anesthesiologists

In 2017, the UN Human Rights Committee warned Italy "concerned about the difficulties of access to legal abortions due to the number of doctors who refuse to practice them for reasons of conscience"







#### **EMERGENCY CONTRACEPTION**

the day-after pill, the five-day pill and the use of the five-day intrauterine spiral are available in pharmacies but are not included among drugs reimbursable or covered by the State.

Since 2015, women over 18 years don't need of medical prescription for emergency contraception.



# Resolution 1607/2008 parliamentary assembly of the Council of Europe

- It recommends that quality abortion services being legal, safe and accessible to all, including non-resident women
  - Member States should regulate and monitor the use of conscientious objection to guarantee assistance
  - -Emphasize that conscientious objection is an individual right and not a collective policy



# AUSTRIA

#### Up to three months

On request

#### Second trimester

- Serious risk to physical health of woman
- Risk to mental health of woman
- Immediate risk to life of woman
- Serious foetal impairment
- Woman is a minor under 14 years

The ability of a woman to pay for an abortion is an important factor

Due to conscientious objection from both medical personnel and hospital management, abortion facilities are not readily available all over the country.



# EMERGENCY CONTRACEPTION

emergency contraception is legal but not among the services repayable or covered by the State. **Emergency** contraceptives are on sale only in pharmacies and can be purchased even without a prescription.

PHARMACOLOGICAL ABORTION legal and accessible.

## BELGIUM

# Up to 12 weeks after conception (or 14 weeks after last menstrual period)

- This can be prolonged as long as the first counselling was before 12 weeks
- No more "state of emergency"

#### No limit

- "Serious" risk to health of woman
- "Extremely serious and incurable disease" of fetus



The woman must receive counselling at least six days prior to procedure, which must be performed by a physician under good medical conditions in a healthcare establishment with the proper information resources.





#### **EMERGENCY CONTRACEPTION**

The day after pill and the five-day pill are both legal and payable in pharmacies, hospitals and health centers even in the absence of a medical prescription.

Included among the drugs reimbursable by the state.

PHARMACOLOGICAL ABORTION legal and accessible.



### **SWEDEN**

#### Up to 18 weeks

- On request

#### Up to 21 weeks and 6 days

- Strong reasons
- In case of serious danger to woman's life or health (with the permission of National Board of Health and Welfare)

Sweden has a very good and well-functioning abortion law but there are some anti-choice activities against the Abortion Act. These groups are mainly connected to a religious sect called "The word of life" (<a href="http://wordoflife.se/">http://wordoflife.se/</a>)



#### **EMERGENCY CONTRACEPTION**

Emergency contraception is legal and available from pharmacies, family planning clinics and hospitals.


For younger girls, the emergency contraception is free. There is no medical prescription requirement for request the day after and five day pill

## CROATIA

#### Up to 10 weeks

- On request

After the 10 week, only if approved by a designated Commission of First Instance

- risk for the health or life (for woman and child)
- child's risk of severe congenital physical or mental defects
- -conception during rape, sexual intercourse with physically helpless or mentally incapacitated person, abuse of position rape, sexual intercourse

As in Italy, Croatia have a very large number of objectors, and there are hundreds cases of women who have been subjected to painful and abusive treatments

## SPAIN

#### Up to 12 weeks

- On request

#### Up to 22 weeks

- in case of risks to the health and life of women or in the case of malformations of the fetus
- If the fetal malformation is such that it does not allow survival outside of the maternal uterus or if the fetus is suffering from an incurable disease, it is allowed to abort even after the 22 week

If the pregnancy is a result of rape, the rape must be reported to the police

There is no policy on conscientious objection, therefore abortions are carred out in very few public hispitals

#### **EMERGENCY CONTRACEPTION**

emergency contraception is legal and available in pharmacies and family planning clinics without a prescription.

In some regions, the cost of the day after pill, the five day pill and the spiral 14 five-day intrauterine is one of the reimbursable drugs

#### PHARMACOLOGICAL ABORTION


Mifepristone and misoprostol are permitted within the first trimester of pregnancy.

However, access is not easy and costs are high. The use of pharmacological abortion is less frequent than the use of surgical abortion.

## POLAND

# Abortion is allowed only in three cases:

- risk for mother's life
- very serious fetus malformation
- rape

Several international institutions, including the European Court of Human Rights and the CEDAW Committee have expressed deep concerns regarding severe consequences of the anti-abortion law on the life and health of women and girls. The restrictive law, the numerous barriers a woman has to overcome in order to secure a legal procedure and the stigma associated with abortion and abortion providers, all contribute to the practice of illegal abortion and high numbers of women and girls travelling abroad for abortion



#### **EMERGENCY CONTRACEPTION**

**Emergency** contraception day after pill and five day pill is legal and available in pharmacies upon prescription by the doctor and is the responsibility of the purchaser. For girls under the age of 18, they can emergency contraception only with the prior consent parents or guardians.

#### PHARMACOLOGICAL ABORTION

The distribution of mifepristone and misoprostol in the is not allowed Country. Technically, since both are included in the list of essential medicines by the WHO, women could buy abortion pills from abroad. Practically however, these pills are often blocked on the country borde


#### From the penal code

"Whosoever, by any food, drink, medicine, or by violence, or by any other means whatsoever, shall cause the miscarriage of any woman with child, whether the woman be consenting or not, shall, on conviction, be liable to imprisonment for a term from 18 months to three years"

"The same punishment shall be awarded against any woman who shall procure her own miscarriage, or who shall have consented to the use of the means by which the miscarriage is procured."

-Information on reproductive health in Malta is very lacking

-Although condoms are sold in pharmacies and supermarkets, the birth control pill is only available on prescription



The day after pill was legalized in 2016, but pharmacists may refuse to sell it based on their "moral convictions".

Maltese women, if they want to practice an abortion, must go to other countries and to Italy, obviously paying for access to a private clinic.

Abortion is really anti-family and anti-motherhood, isn't it?

Abortion and parenthood are not in opposition to each other. Many of the people who access abortion are already parents. Their decision is often influenced by the desire to ensure they can take the best possible care of the children they already have. Parents who choose abortion fully understand what parenting entails and what is needed to adequately care for another child. For people who do not wish to become parents themselves, forcing pregnancy and parenthood on them would in no way strengthen the concept of family life. People are best positioned to decide how and with whom they wish to form a family.

What about abortion in the case of disability or Downs Syndrome?

A diagnosis of Down Syndrome does not mean that a woman who is pregnant will inevitably decide to have an abortion. The majority of pre-natal diagnoses are made at 20 weeks and some countries such as Ireland, have a 12-week timeframe and no exceptions are made on the basis of a disability diagnosis. At the some time, there are already women in Malta who have travelled to England for an abortion based on a diagnosis of disability so the abortion ban is not effective. Providing better support would make parents more likely to continue with a pregnancy after a diagnosis of disability. The solution is not banning abortion but tackling the root cause: prejudice and lack of support for people with disabilities. Furthermore, one in five women lives with a disability and these women sometimes need riportions as well.

VOICE FOR CHOICE









In 1983 the Irish Republic introduced into the Constitution **Eight Amendment** prohibiting women from exercising abortion

Since 2013, the possibility of abortion has been included in the law in the event of a concrete danger to the life of women, following a conviction by the European Court of Human Rights.

Savita Halappanavar, an Irishwoman of Indian origins, who died of septicemia after the doctors denied her an abortion on the 17th week, explaining that "this is a Catholic country"



ON 25 MAY 2018 THE IRISH WERE CALLED TO VOTE ON THE ABOLITION OF THE CONSTITUTIONAL LAW AND. YES WON WITH OVER 66% OF VOTES

Approval of the law "The Regulation of Termination of Pregnancy Bill": it allows to interrupt the pregnancy within the twelfth week in case of fetal anomalies or if the physical or psychological health of the woman should be in danger, but after the consultation with two different doctors.







Irish Republic is one of the major strongholds of Catholicism with 78.3% of believers

Even if the law is a step forward, women who want to have an abortion must face the pro-life that they started to organize real sit-ins in front of obstetric clinics, forcing patients to make their way through small coffins and aggressive slogans

Abortion is legal in England, Scotland and Wales since 1967, but the law was never extended to Northern Ireland, part of the United Kingdom since 1921, as local politicians have always opposed it.

Those who underwent an illegal abortion and those who collaborated could even risk life imprisonment in Northern Ireland.

The Belfast Executive collapsed almost three years ago and the assembly remains suspended, with Northern Ireland currently largely administered from London.

The law concerning abortion, which remained in force for 158 years in Northern Ireland, has finally collapsed thanks to the vote of the Westminster Parliament

Since the Belfast executive was not re-formed by midnight on 21 October 2019, the Northern Ireland Executive Formation Bill and its Amendments, which legalize abortion, are ready to come into force at the beginning of 2020, but already from 22 October 2019 termination of pregnancy will no longer be a crime in Northern Ireland: on that date all ongoing legal proceedings will also be canceled.








In april 2018, the European Parliamentary Forum on Population & Development (Epf) produced a dossier demonstrating the existence of a policy document entitled "Restoring the natural order" produced by an internal group of the european institutions

The 100 to 150 individuals and organizations who make up Agenda Europe come from a diversity of backgrounds, but they all have one thing in common - they share a Christian belief







According to the Epf the document was probably written by "Agenda Europe", a blog today made private, but visible until a few months ago. It is not known who the authors are, but according to the EPF it would be at least two people working in the European institutions, signed with the initials "J.C." and "V.V.", and that they are directed directly to other insiders.



Participants at the Agenda Europa Summit include politics from various countries, and leading people from the World Congress of Families. There are also people close to the conservative and radical right political leaders of various European countries

#### 1995

The idea came from the meeting between Alan Carlson (historian, former official of the Reagan administration and President of the Center for the Family, Religion, Society, a conservative group that opposes abortion, divorce and homosexuality ) and the sociologist and demographer Anatoli Antonov. They decide to funding a NGO based on the shared idea of family. The idea from which they started was that the blame for the imminent demographic collapse that they feared was attributable to the feminist movement and sexual liberation



#### THE ORIGINS OF WORLD CONGRESS OF FAMILIES





The natural family must be composed of man and woman united in marriage

CHURCHES AND PARTIES CAME INTO PLAY LATER, STARTING AN ACTION COORDINATED WITH POLITICAL INSTITUTIONS AGAINST THE ALLEGED ENEMIES OF A "MORALLY FOUNDED" SOCIETY: DIVORCE, HOMOSEXUALITY, WOMEN.

In the same years the UN had organized conferences on women's rights (Cairo 1994, Beijing 1995): for US rightwing groups they constituted an alarm.

- > 1995: Pope John Paul II, Encyclical Evangelum Vitae "No one can authorize the killing of an innocent human being, fetus or embryo" Pope John Paul II called the laws allowing abortion "without legal validity"
- > 1991: Ecclesial White Army Movement: a monument was erected in the cemetery of L'Aquila to the "never-born children", with the consent of the Mayor and the support of the Archbishop. It was the first sign of an anti-abortion escalation an exclation spread over the years.
- > 1997, Piemonte: The Regional Councilor for Health authorizes an anti-abortion association in Novara to organize a macabre 'funeral of foetus' every mont
- > 1999, Rome: two Priests enter the Hospital San Camillo by force to block the urgent intervention for the abortion of a 13-year-old girl, regularly hospitalized with the authorization of the Judge Protect. It was necessary to remove them using the force.
- ▶ 2000, Bolzano: a religion teacher brings plastic fetuses into the classroom, and in the presence of an anti-abortion organization, she forces female students to swear on their present and future chastity.

May 2010, cemetery of the municipality of Cremona: the funeral of 26 fetuses is celebrated. They recited some prayers, "The devil, murderer from the beginning, constantly attentive to the life of man and humanity. Accept, then, O Mary, our consecration because with you we can work effectively in the promotion and defense of life "





#### MARIANNA FUMAI

Marianna Fumai is a filmmaker, interested in looking into social issues with her work. In 2016 in Catania a woman, Valentina Milluzzo, died of sepsis in the fifth month of pregnancy after two weeks of hospitalization. Her family mantain that the day she died, the doctor on duty refused to intervene because of the fetal heartbeat, claiming to be a conscientious objector. For the past two years she has been researching the situation of access to abortion in Italy, Ireland and Poland, three very Catholic countries that share the story of three women who have been refused medical treatment during pregnancy: Valentina, Savita and Edyta. This research would not have been possible without the support of three activists who, with the beauty of their commitment and the deep knowledge of this issue, have supported and still support this project



### ELISABETTA CANITANO Vita di Donna Onlus

Elisabetta Canitano, gynecologist, founded the charity Vita Di Donna to inform women about everything related to their health at the Casa Internazionale delle Donne in Rome. Vita di Donna responds 7 days a week to calls from all over Italy that very often concern the request for information on where to access medical or surgical abortion, without the risk of meeting conscientious objectors. Sometimes some of these women reach her in Rome.



## MARA KLEIN CLARKE Abortion Support Network

Mara Clarke founded in 2009 the Abortion Support Network in order to help those in Ireland, Northern Ireland and the Isle of Man access abortions. ASN helps women with information on the least expensive way to arrange abortion and travel, funding towards the cost, and, when needed, accommodation in volunteer homes. Since February 2019 the organization support women and people from Malta and Gibraltar.





To support freedom of choice and the right to health of women from Poland, Sarah Diehl activist and writer, founded in 2014 Ciocia Basia, an organization based in Berlin. Ciocia Basia makes translations in/from Polish and organizes appointments with counselors and non-judgmental doctors. Volunteers help women to choose the best method for them between medical or surgical abortion, they host women who can not afford accommodation during their stay in Berlin and when necessary, Ciocia Basia funds abortion.



#### WHY THIS FILM?

Sisters is a documentary film project about the lack of fundamental human rights: the right to receive the medical care you need and the right to decide what happens to your body. We assume that in Europe everybody has the chance to decide if and when to become parent, but reality is different.

In Italy, although there is a law "the 194", which regulates access to abortion, in many public facilities it is not available: only around 60% of hospitals equipped with the obstetrics and gynecology wards perform abortions, and not all of them perform therapeutic terminations (those carried out after 90 days of gestation for health reasons). In this framework must be added the conscientious objection provided by law for gynecologists: 7 out of 10 doctors in Italy do not perform abortions. If on the one hand this situation forces people to seek abortion from one city to another and in some cases to other countries with consequent stress and economic expenses, on the other there is an increase of illegal abortions. Furthermore, doctors who apply the law are retiring: over time in fact, conscientious objection has become a channel for career advancement and is no longer just a religious choice.

It is a graphical tool that represents the accessibility of contraceptives and useful information for family planning in 46 European countries. The cost of contraceptives in Italy is totally borne by the citizens.
